NEW PHOTOGRAPHY: New photography will require extra time. Additional fees may apply. No rush service is available.

CONDITIONS FOR PERMISSION TO REPRODUCE WORKS OF ART

Conditions under which permission is granted to reproduce works of art in the collection of Phoenix Art Museum

- Permission is granted for one time usage in one publication, one edition and one language. Additional language additions and subsequent new editions will be considered upon application.
- Reproduction permission is permitted only from photographic materials supplied by Phoenix Art Museum. Reproduction from printed or photographic materials from another source is strictly prohibited.
- The credit line/image caption (as specified by Phoenix Art Museum) must be shown in immediate proximity to the
 reproduction or in the section of the publication devoted to acknowledgements. For broadcasts and films, full credit
 must be included in the program credits, and when applicable, in the accompanying manual.
- Specific permission to crop an image must be requested and granted by Phoenix Art Museum. If an object is not reproduced in entirety, if it is cropped in any way, the image caption must include the word "detail".
- The image is to be reproduced without bleeding, alteration, or overprinting of any kind.
- A color proof must be submitted to Phoenix Art Museum for approval. If the proof does not meet Phoenix Art Museum's requirements, publication rights can be revoked.
- Special permission is required if the work of art is to appear as a book jacket/cover, calendar, poster, greeting card or postcard. The final layout must be submitted to Phoenix Art Museum in advance.
- Two gratis copies of the publication must be sent to Phoenix Art Museum Image Resources upon publication.
- Some works of art are covered by third party copyright. Before Phoenix Art Museum issues permission to reproduce such works, the applicant must obtain written permission from the copyright holder or his authorized agent. A copy of that permission must accompany this request.
- Phoenix Art Museum makes no warranties or representations and assumes no responsibility whatsoever for any
 claims against applicant or the Museum by the artist, their agent, estate or by any parties in connection with the
 reproduction of works of art in the collection of Phoenix Art Museum. The applicant agrees to indemnify Phoenix Art
 Museum and hold it harmless against any and all such claims, including copyright infringement claims, royalty or fee
 demands and/or actions, including the costs thereof arising as a result of the applicant's reproduction of the works in
 the collection of Phoenix Art Museum. Any and all royalty payments or other requirements specified by the copyright
 owner must be paid or honored by the applicant, publisher or agent requesting reproduction permission.
