THE MAIN PURPOSE OF THE MUSEUM IS TO EXPOSE AND EDUCATE THE BROADEST SEGMENT OF THE POPULATION TO THE HISTORICAL AND AESTHETIC ATTRIBUTES OF THE VISUAL AND ASSOCIATED PERFORMING ARTS. OUR FINE ARTS COLLECTION CONSISTS OF MORE THAN 21,000 PURCHASED AND DONATED WORKS. DUE TO THE PANDEMIC, THE MUSEUM WAS CLOSED FOR THREE MONTHS OF THE FISCAL YEAR, BUT STILL WELCOMED MORE THAN 81,000 VISITORS TO THE NUMEROUS EXHIBITIONS, EDUCATIONAL PROGRAMS AND SPECIAL EVENTS DURING THE YEAR. 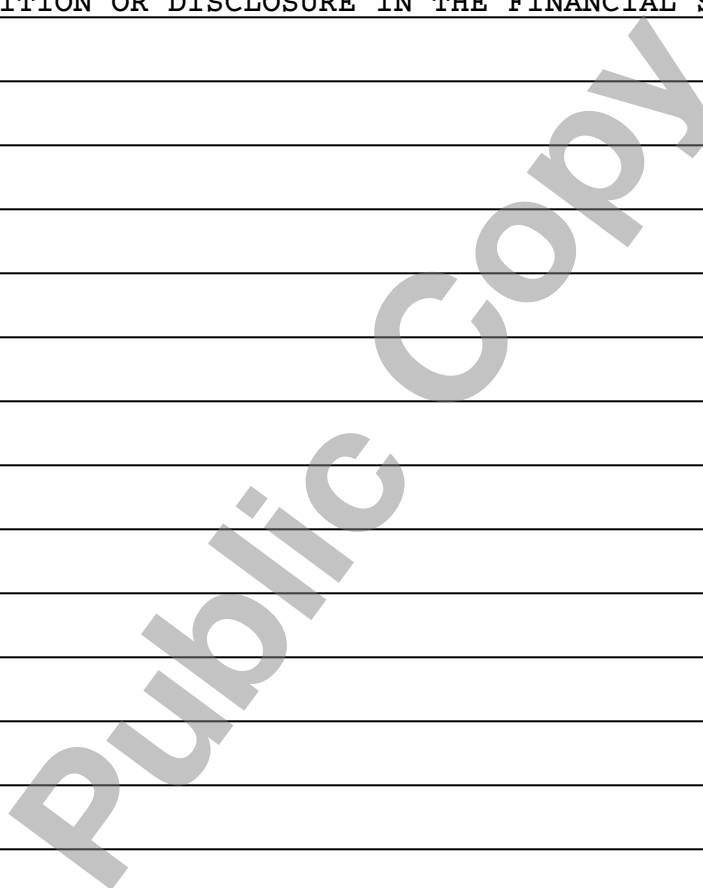

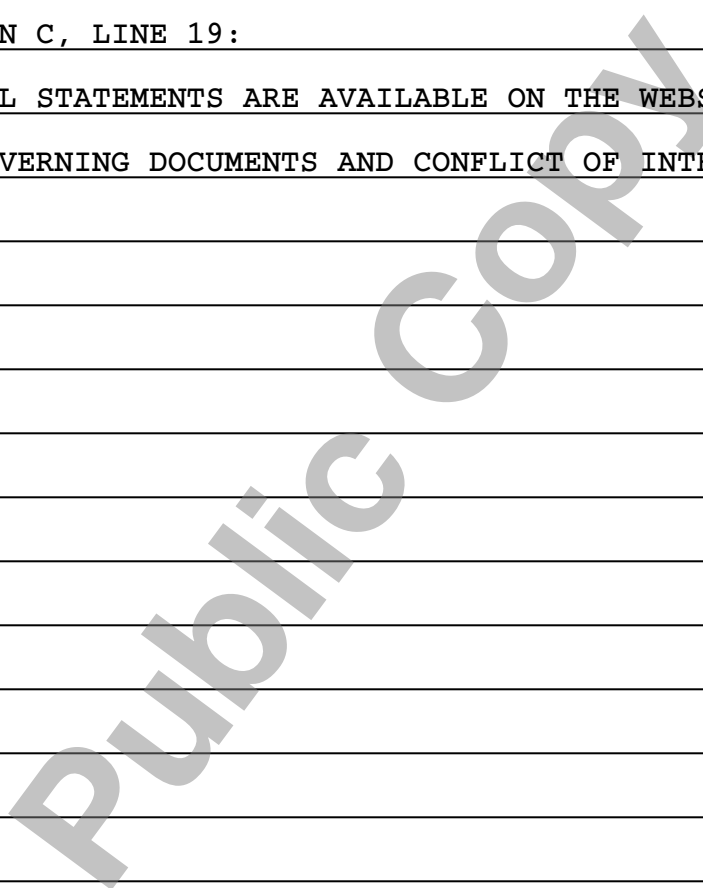
